

Summary approach





The People and Place framework will build on the conversations, workshops and feedback members of the Waterloo community have contributed to over recent years.

Rather than starting from scratch, it will use the insights we already have, identify gaps, and test they are still relevant to the community.





Let's Talk Waterloo

From October to December 2017, we asked Waterloo residents and the surrounding community to share their vision for the future of Waterloo as part of the "Let's Talk Waterloo" program. We heard from over 1,500 people, and their vision for Waterloo encompassed:



A strong and diverse community that celebrates and protects its cultural heritage into the future – in particular, Aboriginal cultural heritage.

A **mix of built, open and green spaces** for private and communal use – where people can connect with each other, celebrating community spirit and diversity through a range of activities and events.

A **connected and accessible Waterloo**, with residents able to access essential facilities, services and shops and a range of frequent of frequent, reliable and sustainable transport options.

A **healthy natural environment with multiple** and diverse green spaces, community gardens, trees, seating and sunshine, providing places to relax and engage.

A **safe and secure Waterloo** where it is easy to move around and connect to open space, services, facilities and transport.

Planning Proposal exhibition

The Waterloo South planning proposal was shared with the community between 3 March to 29 April 2022. During this time, hundreds of residents shared their thoughts on the proposal in face to face and online information sessions. Some of the key themes that the community provided feedback on were:

- Streets and traffic flow
- Trees and sunlight
- Parks and open space
- Car parking and public transport access
- Social and affordable housing requirements
- Heritage and conservation
- Safety and passive surveillance



Our vision

The Waterloo Renewal Project will enhance the strength and diversity of Waterloo, a unique urban village on Gadigal Land. The renewal will deliver new homes, community places, and green spaces which prioritise the health and wellbeing of social housing residents and more sustainable mixed communities.

Build more and better social housing in mixed communities, to meets the needs of residents now and in the future.




Positive social outcomes for residents

Support an inclusive and welcoming community that is socially, economically and environmentally sustainable.







Access to health care services, including a bulk billing GP and Allied Health

Relocations and support

Planning relocations, identifying needed support services, timing and staging relocations to reduce impacts, and providing support before, during and after relocations.



Relocations will happen with at least six months' notice



Relocations will be staged over a number of years



New homes at the Metro Quarter (2024) and Redfern (2026) will be available for relocations



Residents will have dedicated support worker



Residents will have the option to return to Waterloo as new properties become available, as long as they continue to meet eligibility criteria.
