(How will large trucks get into and out of the site - through North Newtown? Erskineville? Darlington? No major roads connect to North Eveleigh)

(6 storey and 12 storey apartment blocks to tower over Conservation Areas. 12 storey does not meet height requirements. Please help reduce building heights)
