'ANTI-SOCIAL' BEHAVIOUR - WE GET IT, THEY DON'T

We all realise that Housing NSW wants to solve some of the problems with anti social behaviour in their properties, but they really seem to be missing the point. It's not just about ending tenancies and moving people out. It is about helping people work out their problems together and getting on with living in sustainable communities.

Why the department won't listen to reason is a mystery, as it would make everyone's life easier including their own. Instead of listening to tenants, who often only want their neighbours to be told to comply with the general rules of living together, a whole procedure of reporting incidents to the police and building cases for the Tribunal is insisted When the department numerous complaints about a tenant, why do they refuse to send them a letter of noncompliance? Most complainants don't want to see their neighbours evicted. They don't want to call in the police, and they most certainly don't want to go to the tribunal. They simply want the landlord to tell the badly behaving tenant to behave in a socially acceptable way.

Many problems are simply not related to tenancies and take place in common areas, such as courtyards, stairwells and open spaces like the Waterloo Green; what measures are being considered to address these problems? Often a simple letter would do. This seems way too simple for Housing NSW, who continue to demand tenants dob each other in, whether they want to or not. This ultimately solves nothing as disputes never get resolved but bubble under the surface, never really being addressed. For many people, especially migrants from authoritarian regimes, the idea of going to a tribunal is anathema.

Yet this seems to be the only solution that the department is offering. It seems bizarre that Housing NSW has morphed a few CSOs (Client Service Officers) into antisocial behaviour specialists when those very officers have refused to come and attend to anti-social problems in the past. Many tenants believe that there should be more general security patrols, and, in large complexes, permanent security guards to create a more secure environment; others would like to see the introduction of building caretakers.

A few years ago the CSOs made 6 monthly inspections to find out if tenants were fulfilling their obligations and if they had any complaints or problems. This practice has disappeared and over the last two years it has become almost impossible to get a CSO to come down and visit some complexes. Many female CSOs will not even make house calls without a male to accompany them and this complicates matters even further.

The department needs to get real and start listening to the tenants rather than just dictating a new version of the same old policies. They could begin by introducing a more appropriate placement policy which would avoid placing potential troublemakers in buildings full of seniors. There are many approaches the department could make if they decided to take on a bit of responsibility themselves and stop expecting the tenants to be their own police force, social

workers and medical service.

\$1,000 to help pay for education



Is Your Child **Starting School Next Year?**

Children who turn five on or before 31st July next year are eligible to start school. By law all children must start school by their sixth birthday.

If parents want their child to go to a state school next year, now is the time to visit their local school and collect an enrolment form.

It is important to do this as soon as possible.

When parents return the form to the school they will need to present their child's birth certificate and immunisation record. Their local doctor can provide the child's immunisation details.

Schools offer a transition program which gives parents and their child a chance to visit the school, meet other families, meet the teachers and gather information about starting school.

Visiting their new school will help children prepare for

starting school next year. If the child has chance to look around the school and meet children and teachers he/she will be more likely to have а more confident start. Parents can ask questions about how the school is going to teach their child.

When parents are at the school, they can find out about the educational program and how their child will be kept safe.

Some of the ways parents can help their child be ready for school are

- Find out about the transition or orientation program at the school.
- Share stories and talk about what might happen next.
- Provide opportunities to play with other children.
- Encourage children to eat independently and use the toilet by themselves.
- Parents who are unsure whether their child is ready to start school can talk to their child's preschool or day care teacher, the principal at the school, doctor or an early childhood nurse.

The Department Education and Training has produced a brochure, 'Time to Start School' which is full of useful information and is available from the school the child will be attending.



Not being able to read makes children feel upset, left out or silly. They can



fall behind their classmates, and they miss out on the joys of reading. There are many reasons why students fall behind in their reading.

The *student 2 student* reading program is run by The Smith Family for children in years 3-8 at Alexandria Park Community School and Our Lady of Mt. Carmel, Waterloo. Children who are behind in their reading are matched up with a "buddy" who is a few years older than them, and has been trained to help them read. The buddy rings the student twice a week for twenty minutes after school and they read over the phone together. The program is confidential - and in fact they are matched with a student from the other side of Sydney. The program is free, and The Smith Family sends out the books needed. S2S has been a great success across Australia and children on the program often become better readers, but more importantly they feel much more confident and feel positive about themselves!

Waterloo Green Landscape Plan update

In response to community concerns, and the findings of the Safety Audit conducted at Waterloo Green during June 2007, Housing NSW became a partner agency in the development of the Waterloo Green Action Plan.

The Waterloo Green Action Plan is supported by a range of government and non-government organisations and seeks to implement a number of strategies which will improve the safety and amenity of the Waterloo Green. As part of it's commitment

to the Action Plan, Housing NSW undertook an audit of external lighting at The Green at the beginning of 2008 and an upgrade program was completed in early July.

In addition, during May and June Housing NSW undertook an extensive process of community consultation with tenants and other community stakeholders to assist it in the development of a landscape plan for Waterloo Green. In early July, tenants and other community stakeholders will be invited to further community information sessions and asked to provide feedback about the sketch plans and proposed changes to Waterloo Green.

The sketch plans will be on display at the Housing NSW Waterloo Office, The Factory Community Centre, Waterloo Neighbourhood Centre, and the Waterloo High Rise internal community noticeboards from **Friday 11–Friday 25 July.** On 15 August Housing NSW will host a free community BBQ for residents and other community stakeholders where the **final plan** will be on display.

Rent rebates: Danger for Housing NSW tenants

The Housing Amendment (Tenant Fraud) Act gives Housing NSW (formerly Department of Housing) new powers to investigate public housing tenants who receive a rental rebate, and new powers to recover rebate monies incorrectly credited to tenants.

The Act also creates a new offence where a public housing tenant intentionally fails to notify Housing NSW of a change in circumstances that affects their rent rebate, punishable by three months imprisonment. Housing NSW will be the prosecuting authority for this and other offences relating to rent rebates.

Public housing tenants who have been incorrectly claiming a rent rebate can notify Housing NSW under a temporary amnesty that will run until 1 October 2008. Tenants who notify under the amnesty are protected from prosecution and proceedings to recover the monies. The amnesty does not apply to public housing tenants who are already the subject of an investigation by Housing NSW.

The TU has expressed concerns that many cases pursued by Housing NSW as 'fraud' are instead cases where there has been a mistake – by the tenant or by Housing NSW – or where the tenant's circumstances simply do not fit well with Housing NSW's policies, or where the tenant is the victim of violence or oppression. The TU will be consulting with Housing NSW to try to ensure these sorts of cases do become caught up in Housing NSW's new powers.

Report below was given by Alison Morgan of Housing New South Wales on Tenant Fraud Legislation and its Implementation to the Central Sydney Division Tenant Forum

OVERVIEW OF TENANT FRAUD LEGISLATION - Alison Morgan

- Handout provided Tenant Fraud Fact Sheet. [contact your local HNSW Office or the HCAP Worker for copy]
- New laws announced 3 April 2008 most significant change is that Housing NSW will be able to create a criminal offence for those who provide false information or intentionally fail to notify of changes in circumstance that remove or reduce a person's entitlement to a benefit.
- Does not apply to just rent, includes Special Assistance Subsidy, Priority Housing looking at changing terminology from tenant to Tenant and Applicant to better cover this aspect.
- Allow Housing NSW to access certain registers (RTA, Maritime NSW, NSW Lands and Office of Fair Trading) for the purpose of preventing, detecting, investigating and prosecuting fraud.
- Introducing new ways to collect debt/recovery debt permit Housing NSW to recover debts owed by reducing or removing a rental rebate, by enforcing repayment from an adult who is not a tenant but who benefited from public housing.
- Targeted for major fraud cases like owning 12 properties not aimed at persons who do not notify minor changes, tenants with mental health or those under duress etc.
- Can only be applied where there is intention and deliberately not notified Housing NSW.
- Exception for Carers living with tenants no criminal charge will be pursued.
- These amendments will not apply to properties owned by the Aboriginal Housing Office or to Community Housing providers and hardship provisions in Housing NSW policies will continue to be developed to ensure these reforms and penalties are applied in a fair and balanced way.
- The Amnesty is key part and will run until 1 October 2008 there is a telephone number to call and for those who self nominate during the amnesty will have their circumstances reviewed without criminal prosecution or the need to repay the rental debt.
- Any reports received will not be investigated until after the Amnesty period expires which will allow for tenants to self nominate.
- Information has gone out in press, on website, communications with tenant groups and mail.
- Being convicted for criminal activity does not mean automatic eviction from Housing NSW.

Housing NSW (Department of Housing) checking tenants get right rent rebates

If you are a Housing NSW tenant you probably get a **rent rebate**. The rent rebate reduces the rent you pay to about 25 per cent of your household income.

To work out how much your rent rebate is, Housing NSW uses the information you give them about:

your income (how much and what type of income)

the income of any other person living with you.

If you give Housing NSW the wrong information, or if things change and you do not update your information, you will get the wrong rent rebate.

If you give them the wrong information on purpose so that you get the wrong amount of rebate, this is called **rent rebate fraud**. This is a crime.

If Housing NSW thinks you are getting the wrong rebate, they can:

stop you getting the rebate

check if you owe them money from the time you started to get the wrong rebate.

If you do owe them money, Housing NSW can:

take you to court to get the money back end your tenancy.

It does not matter if you are getting the wrong rebate on purpose or not, they can still stop you getting the rebate, check if you owe any money and get this money back, and end your tenancy.

Opportunities for improvement

Consumer, Trader and Tenancy Tribunal

The Consumer, Trader and Tenancy Tribunal Amendment Bill is currently before the parliament. Most of the proposed amendments are minor; notable proposals include a new Professional Practice and Review Committee and a new Social Housing Division.

The TU has welcomed the proposed new committee, which would deal with matters relating to tribunal members' training and performance, including complaints against members. The TU is

less enthusiastic about the proposed new Social Housing Division, which would falsely give the impression that the law relating to social housing tenancies is so very different from that relating to other tenancies.

The TU instead suggests that the tribunal should deal with complicated social housing matters by allocating experienced, sensitive members to these matters, rather than by formally establishing a separate division.

The TU understands that the Government intends the amendments to be passed by June 2008.

Residential Tenancies Act

The NSW Office of Fair Trading is considering responses, including the TU's major submission, on the package of over 100 proposals for reform of the *Residential Tenancies Act* and other tenancy laws put forward for comment late last year. The TU understands that a reformed *Residential Tenancies Act* is one of Fair Trading Minister Linda Burney's "priorities for 2008."

USA JAIL - SOME INTERESTING READING TO THOSE OF YOU NOT FAMILIAR WITH JOE ARPAIO, HE IS THE MARICOPA COUNTY SHERIFF (ARIZONA) AND HE KEEPS GETTING ELECTED OVER AND OVER AGAIN.

These are some of the reasons why:

Sheriff Joe Arpaio created the 'tent city jail' to save Arizona from spending tens of millions of dollars on another expensive prison complex. He has jail meals down to 20 cents a serving and charges the inmates for them.

He banned smoking and pornographic magazines in the jails, and took away their weightlifting equipment and cut off all but 'G' movies. He says: 'They're in jail to pay a debt to society not to build muscles so they can assault innocent people when they leave.' He started chain gangs to use the inmates to do free work on county and city projects and save taxpayer's money. Then he started chain gangs for women so he wouldn't get sued for discrimination. He took away cable TV until he found out there was a federal court order that required cable TV for jails. So he hooked up the cable TV again but only allows the Disney channel and the weather channel.

When asked why the weather channel, he replied: 'So these morons will know how hot it's gonna be while they are working on my chain gangs.' He cut off coffee because it has zero nutritional value and



is therefore a waste of taxpayer money. When the inmates complained, he told them, 'This isn't the Ritz/Carlton. If you don't like it, don't come back.' He also bought the Newt Gingrich lecture series on US history that he pipes into the jails. When asked by a reporter if he had any lecture series by a Democrat, he replied that a democratic lecture series that actually tells the truth for a change would be welcome and that it might even explain why 95% of the inmates were in his jails in the first place.

With temperatures being even hotter than usual in Phoenix (116 degrees just set a new record for June 2nd 2007), the Associated Press reported: About 2,000 inmates living in a barbed wire surrounded tent encampment at the Maricopa County Jail have been given permission to strip down to their government-issued pink boxer shorts.

On the Wednesday, hundreds of men wearing pink boxer shorts were overheard chatting in the tents, where temperatures reached 128 degrees. 'This is hell. It feels like we live in a furnace,' said Ernesto Gonzales, an inmate for 2 years with 10 more to go. 'It's inhumane.' Joe Arpaio, who makes his prisoners wear pink, and eat bologna sandwiches, is not one bit sympathetic. 'Criminals should be punished for their crimes - not live in luxury until it's time for parole, only to go out and commit more crimes so they can come back in to live on taxpayers





Housing NSW Youth Scholarships

APPLICATIONS NOW OPEN

More students complete year 12 or recognised vocational training Applications have opened for a unique Housing NSW scholarship program that encourages disadvantaged students in public, community and aboriginal housing to stay in school and reach their full educational potential.



Launching the 2009 Housing NSW Youth Scholarships Minister for Housing Matt Brown said the program will award 100 students with \$2000 each to spend on their educational needs. "These scholarships aim to encourage and support young social housing tenants to stay at school and complete their higher school certificate," Mr Brown said.

"The scholarships hope to breakdown educational barriers faced by disadvantaged students and to close the educational gap between students who live in public and privately-owned housing." Mr Brown said the achievements of previous recipients proved the scholarships were a great help to students. "In 2007 Aboriginal scholarship recipient John Randall from Evans Head became the first young man from his community to complete the HSC. He is a great role model to other students feeling the pressure to leave school," Mr Brown said.

"Jasmin Owen from Cowra purchased a computerised sewing machine with her scholarship funds for use in her Textiles and Design Studies course. Now Jasmin has the opportunity to achieve her goal of a career in design or theatre." "And Paul Gurrea from Woolloomooloo was able to pay for a new computer and maths tutoring to help him towards his goal of becoming a teacher." Mr Brown said the scholarships would be managed by the students' educational institutions and could be spent on items such as computer equipment, tutoring and text books.

"To be eligible students must be under 25 years old, live in or be on the waiting list for social housing, be studying Year 11, 12 or TAFE and their school or TAFE must endorse that they are likely to have a good attendance record," Mr Brown said. "These scholarships are part of the lemma Government's Youth Action Plan 2006 – 2010 and the NSW State Plan. They contribute to a new direction in the delivery of social housing – making sure young people not only have a roof over their heads, but have the opportunity to make their future aspirations achievable."

"We want to make sure young people living in social housing have every opportunity to complete their HSC and move on to higher education, if that is what they want to do." Application forms are available on the Housing NSW website www.housing.nsw.gov.au and close on August 1 2008.

"Applications for scholarships are now open and I encouraged all young people and parents living in social housing to apply," Mr Brown said.

We understand from those who attended the Human Services Ministerial Advisory Committee that an initial Draft Evaluation of the Human Services Plan Phase 1 was going to the Senior Officers Group (ISOG) in June and should be released in the near future. The Human Services Plan Phase 2 is also close to being released and a forum of service providers is being planned to discuss its implementation. We are unsure at this point what level of community involvement there will be in this process. There has also been an evaluation of the Case Coordination Unit completed. Although the Human Services Team is due to finish at the end of June 08, the RWA and ISOG will continue to monitor and evaluate the implementation of both plans.
